copy annexed, adopted on December 14, 2020 by majority vote of the Board of Directors and by the vote of the stockholders owning or representing at least two-thirds of the outstanding capital stock, and certified under oath by the Corporate Secretary and a majority of the Board of Directors of the corporation was approved by the Commission on this date pursuant to the provision of Section 15 of the Revised Corporation Code of the Philippines, Republic Act No. 11232, which took effect on February 23, 2019, and copies thereof are filed with the Commission.

Unless this corporation obtains or already has obtained the appropriate Secondary License from this Commission, this Certificate does not authorize it to undertake business activities requiring a Secondary License from this Commission such as, but not limited to acting as: broker or dealer in securities, government securities eligible dealer (GSED), investment adviser of an investment company, close-end or open-end investment company, investment house, transfer agent, commodity/financial futures exchange/broker/merchant, financing/lending company and time shares/club shares/membership certificates issuers or selling agents thereof; nor to operate a fiat money to virtual currency exchange. ARTICLES OF INCORPORATION OF

SMC TOLLWAYS CORPORATION

(formerly ATLANTIC AURUM INVESTMENTS PHILIPPINES CORPORATION

As amended on December 14, 2020)

KNOW ALL MEN BY THESE PRESENTS:

The undersigned incorporators, all of legal age and majority of whom are residents of the Philippines, have this day voluntarily agreed to form a stock corporation under the laws of the Republic of the Philippines

AND WE HEREBY CERTIFY THAT:

FIRST - The name of said corporation shall be:

SMC TOLLWAYS CORPORATION (As amended on December 14, 2020)

SECOND - The purposes of this corporation are:

PRIMARY PURPOSE

To invest in, purchase, or otherwise acquire and own, hold, use, sell, assign, transfer, mortgage, pledge, exchange, or otherwise dispose of real and personal property of every kind and description, including shares of stock, bonds, debentures, evidence of indebtedness, and other securities or obligations of any corporation or association for whatever lawful purpose or purposes the same may have been organized, including but not limited to those engaged in the logistics, tollways, infrastructure and similar businesses, and to pay therefor in money or by exchanging therefor stock, bonds, or other evidences of indebtedness or securities of this or any other corporation; and while owner or holder of any such real or personal property, stocks, bonds, debentures, evidence of indebtedness, and other securities or obligations of such stock, to receive, collect, and dispose of the interest, dividends, and income arising from such property, and to possess and exercise in respect thereof all the rights, powers and privileges of ownership, including all voting powers of any stock so owned without acting as broker or dealer of securities.

SECONDARY PURPOSE

1. To own in accordance with law, lease, construct or otherwise acquire, own, hold, manage, operate, maintain, sell, lease, or dispose of, ports, warehouses, cold storage vaults, refrigerating equipment, and other structures with the real estate necessary therefore, as may be necessary or useful for the achievement of the primary purpose of the corporation.

- 2. To own or lease all kinds of, motor vehicles, ships, boats, vessels, as well as aircrafts, as may be necessary to carry out the primary purpose.
- 3. To apply for, obtain, register, purchase, lease, or otherwise acquire, and to the extent authorized by law, to hold, use, own, operate, develop and introduce, sell, assign, and otherwise dispose of any trademarks, trade names, distinctive marks, patents, inventions, improvements and processes, used in connection with, or secured under letters patent of the Republic of the Philippines, or elsewhere or otherwise, and necessary or useful for the achievement of the primary purposes of the corporation in connection with the business of the Corporation, and to use, exercise, grant licenses in respect of, and otherwise, turn to account, any such patents, inventions, processes and the like or any such property rights.
- 4. To own, register, or acquire license for all types of software and data bases in relation to electronic commerce technology or as may be necessary to carry out the aforementioned businesses.
- 5. To enter into, make, perform and carry out contracts of every kind and for any lawful purpose, pertaining to the business of the corporation, or in any manner incident thereto, as principal agent, or otherwise, with any person, firm, association, or corporation.
- 6. To borrow such sums of money, and to contract such debts, from time to time, as may be deemed necessary for, or of aid in the accomplishment of, any of its lawful purposes or objects; to execute, issue and dispose of its promissory notes, bonds, debentures, certificates, and other negotiable or transferable instruments or other securities, or evidence of indebtedness, for any monies, so borrowed, or debts so contracted, and to secure the same by pledge of any of its personal property, or by mortgage or mortgages, or deed or deeds of trust, upon any, or all, of the assets, properties, concessions, subsidies or franchises of the corporation, or by deeds constituting liens and charges upon and affecting the income and revenue of its properties, in whole or in part, upon such lawful terms and conditions, as may be set forth in the instrument or instruments mortgaging or affecting the same, or in any contract, deed or instrument, relating thereto; to confer upon the holder of any debentures or bonds of the corporation, secured or unsecured, the right to convert the principal thereof into stock of the Corporation, upon such lawful terms and conditions, as shall be fixed by the Board of Directors, all subject to the limitations established by the law.
- 7. Generally, to do and perform all such things, transact such business, exercise such power and authority as may be directly or indirectly necessary, suitable or proper for the accomplishment of its purposes or the attainment of any or more of the objects therein enumerated, or which shall appear at any time conducive to, or expedient for, the Corporation or which have been conferred by law upon corporation of like nature.
- **THIRD** The place where the principal office of the corporation is to be established is at 11/F San Miguel Properties Centre, 7 St. Francis St. Mandaluyong City. (As amended on December 14, 2020)
- **FOURTH -** The term for which the corporation is to exist is fifty (50) years from and after the date of issuance of the certificate of incorporation.

SEVENTH - The authorized capital stock of the corporation is EIGHT BILLION PESOS (\$\text{P}8,000,000,000.000\), in lawful money of the Philippines, divided into EIGHTY MILLION SHARES (80,000,000) shares with a par value of ONE HUNDRED PESOS (\$\text{P}100.00\) per share.

There shall be no pre-emptive rights on any issuance of shares by the corporation.

EIGHTH - At least twenty five percent (25%) of the authorized capital stock has been subscribed and at least twenty five percent (25%) of the total subscription has been paid as follows:

NAVARRA has been elected by the subscribers as Treasurer of the corporation to act as such until his successor is duly elected and qualified in accordance with the by-laws; and that as such Treasurer, he has been authorized to receive for and in the name and for the benefit of the corporation, all subscriptions paid in by the subscribers.

ELEVENTH - The incorporators undertake to change its corporate name, as herein provided or as amended hereof, immediately upon receipt of notice or directive from the Securities and Exchange Commission that another corporation, partnership or person has acquired a prior right to the use of that name or that the name has been declared as misleading, deceptive, confusingly similar to a registered name, or contrary to public morals, good customs or public policy.
